- 2. The meeting was called to order at 5:18 pm by Waqas Yousafzai, Acting Meeting Chair / Parliamentarian.
- 3. The 2014 AGM Agenda was presented.
 - a. Motion: Michelle Oucharek-Deo proposes an addition to the agenda under New Business to discuss BCATA/CATA/OATA alliance.
 Moved: Michelle Oucharek-Deo Seconded: Heather Sanrud Vote: Unanimous
 - b. Point of Order: Nick Zwaagstra questioned why Waqas Yousafzai is chairing the meeting as opposed to the CATA President, Mehdi Naimi. Mehdi read the bylaws that indicated that the President presides at all AGMs, but there is no indication that the president has to chair the AGM.

The President is able to appoint others to chair the AGM.

- d. Mehdi Naimi shared that Honorary Members may not be able to vote. Jaqueline Fehlner expressed that Honorary Members not being able to vote is unfair. After verification of the bylaws, Mehdi Naimi clarified that Honorary Members can indeed vote.

- 4. The 2013 AGM minutes were accepted as written with the following amendments:

 NOTE: Tzafi became a Registered member on Feb 14/14, so as of the date of the 2013 AGM, she was a Professional level member.

- Presentation of the Annual Report in written form and sent out electronically was accepted as written.

 Vote: Unanimous (26 Yes) (0 No) (4 Abstained)
- 6. Gilda Raimondi, CATA Treasurer, presented the unaudited financial statements dated Oct 1/12 to Sep 30/13 and a second one dated Oct 1/13 to Jun 30/14 reflecting the new fiscal year-end.

a. Question: Michelle Oucharek-Deo asked how many CATA members there currently are. Answer: Mehdi Naimi stated the Annual Report shows 485 members as at Jun 30/14. The most current number is approximately 520 members.

b. Question: Michelle Oucharek-Deo inquired as to why the revenue seemed low given the membership numbers, as they were multiplying the number of professional members by 105 and found that CATA should have had more money than they showed in the report.
 Answer: Gilda Raimondi and Mehdi Naimi clarified that there are various levels of membership (professional, student, etc.) whose annual fees range from \$25 to \$105. Therefore the total income comprises of the sum of the various levels of membership.

c. The two unaudited financial statements were accepted as written. Moved: Sharona Bookbinder Seconded: Tatjana Jansen Vote: Unanimous (19-Yes) (0-No) (19-Abstained)

- 8. Presentation of the new bylaws and new constitution (Canada NFP Corporations Act Form 4031).
 - a. Amendment: Correction to the name change from Art Thérapie to Art-Thérapie in the bylaws and the new constitution offered by Deborah Behnke and Lucille Proulx.
 - b. Question: Whether to include CATA acronym in the registered name by Nick Zwaagstra. Answer: Mehdi Naimi explained that the acronym will appear in official documents, but to include it in the official name would repeat the name.
 - c. Amendment: Change "and" to "or" on the last line in Article 7 by Nick Zwaagstra.
 - d. Question: Could we please clarify what "majority" means in Article 24 by Nick Zwaagstra.
 Answer: Waqas Yousafzai suggested that "majority" could be defined in Article 1. Meaning (50 % + 1).
 - Question: Ensure that the voting privileges acknowledge Honorary Members as being able to vote by Nick Zwaagstra.
 Answer: Mehdi Naimi clarified that Honorary Members can vote.
 - f. Question: Michelle Oucharek-Deo asked what happens to the nuances of CATA as an association if the bylaws are too generalized and proposed transporting the old Bylaws into the new charter document.
 - g. Motions submitted by proxy by Darlynne Hildebrandt were moved to the following AGM due to time constraints. These include the non-specificity of the bylaws and the following articles: 21, 27, 32, 33, 34, 36, 41, 42.
 - Motion: CATA will devote a designated amount of time during the AGMs to continually develop the bylaws.

 - i. Bylaws and charter documents were accepted as written for official submission to Industry

- b. Moved: Nick Zwaagstra , Olena Darewych and Darlynne Hildebrandt moved that Waqas Yousafzai not be elected as Governance Director because only CATA Registered and Professional Members are able to be part of the board. Mehdi Naimi and Waqas Yousafzai discussed that the majority of non-profit associations have board members of various professions to share their diverse expertise, and Waqas Yousafzai has an academic and professional background in policy and governance.
- c. Olena Darewych (by proxy) Moved: That Josette Steel not be elected at the AGM as Membership Director because nominee's names and information should be sent out 30 days before the AGM and hers was not. Discussion: Mehdi Naimi acknowledged that Josette Steel was added to the nominee list after the original time the document was sent prior to the AGM. Furthermore, CATA has traditionally asked for nominations from the floor at the AGM only a few minutes before voting, but are no longer doing that as they are now checking the nominee's qualifications before, ensure their commitment to volunteer their time, to avoid the rush at the AGM, etc. Consequently it is somewhat of an exaggeration to ask for 30 days' notice that requirement was ignored in all of the previous AGMs.

We received requests for information about educational standards and about the job markets from folks in Israel, Jordan, Korea, Japan, South Africa, Iran, Thailand, Scotland, Switzerland and others. It is impressive to see the full geographic scope of our profession as it grows in numbers and nationalities. We also completed the five-year school review. Art therapy Schools in Canada were invited to participate by completing documentation and substantiation of the ten educational standards set several ago in our CATA standards document described on our website. You can find a summary of the results on a newly designed educational matrix on the CATA website. This matrix realizes the goal CATA set to increase support to the schools, increase accountability of aligning with the standards and providing a service to the public and potential

Working as the CATA Communications Chair in the 2014-2015 term has been both challenging and rewarding. The Communications team has made many strides, such as hiring Taylor & Francis as our new publishers and recruiting new and motivated volunteers, such as Marilyn Magnuson (Journal Guest Chief Editor), Andrea Hrysko (Social Media Chair), Sandra-Hewitt Parsons (E-blast Coordinator and Social Media Committee), Krista Schneider (Newsletter Editor), Anne Walsh (Newsletter French Translator), Emilie Luc (Social Media Facebook Committee). We have a lot of work ahead of us to maintain these strides and reach new goals.

We have been fortunate to retain very motivated volunteers, such as Nathalia Gagnon (Newsletter French Translator), Marjorie Lavoie (Journal and Newsletter Proofreader), Tatiana Peet (Journal Book Review Coordinator) and Dianne Shannon (English Proofreader). Your priceless dedication to increasing communication for our nation-wide community of art therapists is extremely appreciated. I am truly grateful for your talents and enthusiasm.

The CATA-ACAT Newsletter committee has published Volume 14: Issue 1 and 2 in the Spring and Summer of 2015. Our upcoming Fall newsletter will be published in November 2015. Highlights include: talented poetry, committee updates, news from art therapy institutes and universities, and conference survey results.

Having Taylor & Francis as our new publishers has created many changes. Changes include: manuscript submission process, peer review methods, which is now double-blind as opposed to single-blind, new cover image and binding, international promotion of the journal and the online library database. These changes increase CATA-ACAT's ability to promote Canadian art therapy scholarly research on an international platform. The accessibility and review process is increasingly becoming digitalized, which ensures the ethical standards of reviewing and increases our professionalism.

In March 2015, Marilyn Magnuson and I met with the Taylor & Francis team in Philadelphia, where we strategically planned the new changes. Due to the low submission rate of

manuscripts for our journals, we were unable to publish a journal in the summer and will be creating a double-issue at the end of 2015. Therefore, I would ask our members to continue submitting empirical research with respect to the American Psychological Association guidelines. Furthermore, CATA-ACAT is looking for more Master's and PhD-level reviewers who are able to dedicate their time to reviewing submitted manuscripts. At present there are three accepted articles and three book reviews sent to publishing; three articles and one book review sent back to authors for revisions; and one new article under review. Thank you to our Editorial Review Board Members: Sherry Beaumont, Jaqueline Fehlner, Amanda Gee, Jo Ann Hammond-Meiers, Stephanie Kellington, Marjorie Lavoie (French), Mary Norton, Ara Parker, Tatiana Peet (Book Reviews), Heather Sanrud, Sri Transken, and Judy Weiser (phototherapy).

Special thanks also goes out to our Social Media Committee. CATA-ACAT has been very active on diverse online platforms by posting via Hootsuite. Our public Facebook membership has reached 849 members, with our last post reaching 2,556 people. Furthermore, we have also created a presence on LinkedIn (68 followers), Twitter (246 followers), and Instagram (60 followers) and Google+ accounts. Sandra Hewitt-Parsons, the Social Media Committee Chair, is looking for images to include in our content, connections with different associations and more followers to participate and contribute on these platforms.

Additionally, CATA-ACAT's logo contest this year had many talent-filled submissions that encapsulated our new bilingual logo. Katie Hanczaryk was the winner of this contest, whose thoughtful logo's colours represent our rich French-English cultural heritage. Both of these languages combine in the logo to represent the harmonious connection while also retaining their independent identities.

Our goals for the upcoming year are to continue to "raise the profile" on all communications platforms: by increasing bilingual and culturally inclusive content, recruiting new talented volunteers, increase journal manuscript submissions and design a new and dynamic mobile-friendly website. CATA is still looking for talented people to volunteer as the Newsletter Chair (Editor), Website Chair and Marketing & Promotion Chair. Filling these roles would ensure that each component of our communications team runs smoothly, as we need a lot of people-power to complete every task with care and consistency. Thank you for the opportunity to be your Communications Committee Director and I look forward to our future as an association.



Governance Report

I got involved with the organization in a June 2014 workshop held in Parksville, BC to work towards organizational by-law updates that needed to be in compliance with the new Not-for-profit (NFP) Corporations Act. At the 35th AGM in Nelson, BC, a new appointed position of Governance Advisor to the executive board was created with an exclusive focus on drafting by-laws and consulting the broader membership on the specific text of by-laws. This position was also tasked to put in place other aspects of governance, specifically policies and procedures that had been administered in an ad-hoc fashion and maintained verbally.

Since securing our NFP Articles of Continuance in 2015, there has been a redoubling of energy and a concentrated focus to anchor the organization administratively and increase its efficiency. To this end, in 2015, membership will undoubtedly notice an abundance of new initiatives across all areas. This includes the newly launched and internationally accessible electronic journal, new website facelift and logo, new vision and mission statements, inclusion of French to reflect both official languages, and internal work towards the formalization of procedures and policies, just to name a few.

In 2014-2015, under the Governance portfolio, I drafted, consulted, presented, and put forward some core policies for adoption to the CATA-ACAT board. The following policies were voted on and inform the organization's decision making:

- Annual Conference Expense Reimbursements
- Lapsed Memberships Policy
- Organizational Privacy Policy
- Social Media Policy and Guidelines
- Revised Board of Directors Application

In addition to the policies above, there were 3 separate by-law membership consultation sessions held on CATA-ACAT forums which were open to all members. The final text of the

organizational by-law is being presented at the 36th annual conference in Halifax for adoption by the organization.

As a taste of what can be expected in the 2015-2016 term, the governance area will be presenting a confidential ethics complaint mechanism and working closely with memberships and registration committees to ensure a consistent policy on membership and its renewal. We will also be looking at supervision standards and developing our alliance agreement with provincial associations to make the profession uniform across Canada.

MEMBERSHIP REPORT

At the beginning of the year, we welcomed returning Professional member, Josette Steel, to the position of Membership Director. Unfortunately, due to some unexpected life changes, Josette was unable to complete her year as a Board member and stepped down at the end of January, so the remaining year was managed by the Board with support by contracted services.

We are happy to have Amanda Gee, Registered member from North York, ON, standing for election as Membership Director at this AGM to govern Membership, Nominations, Registration and Volunteer Management Committees. She will be looking for people interested to lead or be part of these committees once she's 'in the job', so if you know one of these committees is an area of interest for you, please contact her at catamembership@gmail.com.

MEMBERSHIP:

This year was another banner year for membership growth, seeing a 73 member increase overall. There are many things that contribute to this healthy growth – a successful conference in Nelson, promotion of membership through the schools, art therapy becoming better known and thus more interest in training, responsiveness to the needs of the membership. We can't really say for sure, but we are happy with the growth!

What's New?

- Membership renewal dates were changed so that renewal requests would be sent out at the beginning of the month that the member is due to pay in and they would have until the end of the month to pay. This has helped with administrative functions and also gives the member a 30-day window to get their payment in on time.
- New information categories on the Member Profiles to help identify volunteers, skills & talents unrelated to art therapy, as well as information to assist with statistics.
- We created two more membership levels in order to accommodate the needs of our membership:

- 1) Associate Student for students not enrolled specifically in an art therapy program at this time, but are interested in entering into one in the near future.
- 2) Associate Professional for Professional or Registered members on temporary or permanent leave. With a predominantly female member population, we often have had members lapsing as they went on maternity leave. We are encouraging them to stay involved with this level where they can maintain their privileges of membership, while they take a year or more off from working. It is also meant for ATs that are retired and no longer need the Professional or Registered level credential, but wish to remain a part of CATA. This could also be used for an extended sick leave or long-term travel. Basically meant to give a price break to those not practicing in a particular year.
- The membership rates increased after many years to accommodate the rising costs associated with our growth and to keep in line with what other associations are charging both in Canada and elsewhere. We also leveled the fee structure so that Professional and Registered members pay the same annual fee given they get the same benefits for their membership.

NOMINATIONS:

This was a non-existent committee this year, but so very necessary as we move into the future to be earnestly seeking strong leadership for the Board positions. The current Board and contracted services supported getting the nominations for this AGM.

REGISTRATION:

Adrianna (Adri) Leinberger, Registered member from Winnipeg, MB, took on the leadership of this committee last year and with the support of her committee members, Betty Bedard-Bidwell (Goderich, ON) and Anna Sousa (Stoufville, ON) have been doing a great job in processing the registration applications. There were 18 successful applications this fiscal year, up from 13 in the previous year.

What's New?

- This was the first year of trying to assess the applications by committee. In the past, we relied on one volunteer to do everything which had proved to become quite a burden.
- The registration certificate was revamped to include the new logo and to make it a bilingual document to further promote the fact that we are working towards becoming a bilingual organization in support of our French-speaking membership. The new size also makes it easier for printing, mailing and for the recipient to have easily framed.
- New registrants will now be acknowledged in the CATA newsletter to mark their accomplishment and to allow our community to celebrate their achievement.

Future Plans:

• Revamp the application package to enhance clarity and simplicity without losing the integrity of the process as there have been complaints from members about the difficulty and duplication they experience in the present format.

- Discuss the pros and cons on requiring continuing education credits to maintain one's annual registration status.
- Discuss the possibility of moving from static dates for applications to open all year round.

VOLUNTEER MANAGEMENT:

This was a non-existent committee this year, so all needs were provided by contracted services. We are currently operating with about 40+ volunteers with some people doing multiple jobs.

We still have many vacancies to fill and encourage our membership to get involved. If you have an expectation of walking into a pre-made structure that you just maintain, then volunteering for CATA may not be right for you. We are seeking entrepreneurs – If you want to take an area and create something out of nothing with your vision and our help, then let's make it happen! Let's help CATA be the voice of art therapy in Canada!
